


2. Contract Clause B.7, "Re-Opening Fee Negotiations," is hereby incorporated into Part I, Section B, "Contract Clauses." Contract Clause B.7, "Re-Opening Fee Negotiations" is stated below in its entirety.

B.7 RE-OPENING FEE NEGOTIATIONS

In the event the Fee Base deviates, for the period October 1, 2003 through September 30, 2004, more than plus or minus 15% from the Fee Base as set forth in Contract Clause B.3, "Estimated Cost and Fee", the Contractor and the Government agree to negotiate an adjustment to the Available Performance Fee amount to reflect the impact of the deviation. Negotiations for the new Available Performance Fee amount will be conducted in accordance with DEAR Subpart 970.15, "Contract Negotiations," and consistent with the fee computation methodology for the period October 1, 2003 through September 30, 2004. In the event the parties are unable to reach agreement upon re-opening fee negotiations, the Government reserves the right to unilaterally establish the Available Performance Fee.
